ADMISSION TO SOUTH AFRICA: DELEGATES TO ATTEND THE FIFTH GLOBAL CONFERENCE ON THE ELIMINATION OF CHILD LABOUR: DURBAN INTERNATIONAL CONFERENCE CENTRE (ICC): 15 – 20 MAY 2022

Visas may be issued to bona fide delegates attending the above mentioned event, provided a letter of invitation is submitted / name list of persons appointed by Government / organisations (copies also accepted), if nothing detrimental is known and they are not prohibited or undesirable in terms of the Immigration Act 2002, as amended.

Visas may not be issued to delegates whose journey starts or entails passing through the yellow fever belt of Africa or South America if they are not in possession of yellow fever certificates. The Yellow Fever Certificate is not required if a person remains in transit for less than 12 hours.

PLEASE BE INFORMED THAT FOR AN EVENT HOSTED BY ANY GOVERNMENT ENTITY THE ORGANISERS ARE NOT REQUIRED TO SUBMIT PROOF OF IDENTIFICATION.

Kindly take note where applicants originate from countries where South Africa has no Mission, the applicants may send their applications by mail or courier to the Mission as per the attached list. The list is subject to change.
