Port Health Services

Environmental Health Practitioners (EHP's) are based at designated points of entry and they are responsible to implement the legislative mandates that guide the activities of Port Health.

- All points of entry will be adequately manned as per the operational hours of the point of entry.
- An average of five (5) EHP's will be on duty per shift at OR Tambo and King Shaka airports.
- Port Health activities which include monitoring and surveillance for communicable diseases and its reservoirs and vectors, will be up scaled from 10 to 15 May 2022, to permit for efficient screening of travellers who will be arriving and departing the country, including the inspection of goods that they will be bringing with them.

Port health will work closely with eThekweni Municipality Environmental Health Services

ACTIVITIES TO BE CONDUCTED DURING THE MENTIONED OPERATIONAL PERIOD

- 1) Implement COVID-19 screening measures for all arriving travellers at the point of entry including airline crew and ensure compliance to health directions
- 2) Health monitoring, surveillance, inspection and clearance of all international conveyances entering the Republic through the point of entry
- 3) Monitor the vaccination status of all travellers arriving within the incubation period from yellow fever endemic areas
- 4) Monitoring and surveillance of rodent and vector activity on conveyances and in the point of entry
- 5) Monitor and control the importation and exportation of mortal remains through the point of entry
- 6) Conducting health and hygiene education at point of entry

ACTIVITIES TO BE CONDUCTED Continued....

- 7) Monitor the importation of foodstuffs, cosmetics, medicaments to ensure compliance
- 8) Implementation and activation of Outbreak Response Plan should surveillance or reporting reveal a suspected case of a Communicable Disease.
- 9) Activation will include Port Health communication with EMS and the CDC coordinators
- 10) Refer to hospital when warranted for isolation or admission
- 11) Provide Emergency Medical and Primary Health Care services at ICC
- 12) Activate EMS response when there is an emergency at ICC

Hospital Services



a) For delegates who may fall sick and require hospitalization or in – hospital emergency care the following hospitals will be activated:

- Addington hospital
- King Edward Hospital, King Dinuzulu
- Inkosi Albert Luthuli Hospital (For Poly-trauma)



b) Isolation of Symptomatic COVID-19 Cases

Onomo Hotel, South Beach Garden Court and Protea Edward Hotels have been accredited as Quarantine / Isolation Facilities for travelers.

- The cost will be borne by the individual travelers
- Clairwood Hospital for Isolation of positive cases

c) For patients with travel insurance and who prefer private hospital, the following hospitals will be activated:

- St Augustine
- Entabeni Hospital
- Umhlanga Hospital



d) Repatriation of Body Remains

Should a delegate from another country demise, the South African regulations for repatriation of remains will apply with collaboration with Department of International Relations and Cooperation (DIRCO)

Special Considerations

Isolation Ambulance

- If a delegate presents with any signs and/or symptoms that may indicate one of the known diseases, the individual is immediately isolated within the dedicated KwaZulu Natal Emergency Medical Services Isolation Ambulance stationed at the Durban Exhibition Centre and will be attended to by the dedicated medical crew attached to this area.
- The delegate will be transported to Addington Hospital – isolation unit for further medical management or to the private hospital dependant upon their medical insurance.

Hospitalisation

- Medical treatment will be restricted to primary, immediate and emergency care only and will be provided at no cost
- Any condition requiring ongoing or specialized treatment will be referred to a health care facility
- Special investigation or service or hospital admission will be to the cost of the delegate



Medical Plan for the Conference

During the reporting period, Port Health and KZN DOH Services will continue to actively enhance monitoring and surveillance of all international conveyances and travelers, by

- actively screening travelers,
- ensuring that traveler health questionnaires are completed
- verifying the validity of COVID-19 PCR test results; including yellow fever vaccination certificates for respective arriving travelers

All requirements as prescribed by the International Health Regulations (2005) would be applied should an alert be issued. South African delegates requiring vaccination will be offered Vaccination on site.

- ***NB: All delegates from outside the country will be required to produce proof of vaccination and that they will have travel insurance.**
